

LEGAL DOCUMENTS AUTOMATION - CAPABILITIES WITH



- 1.100% of the legal documents could be automated -no matter the complexity apply most complex decision trees and conditionality logic on legal drafting -e.g SPA for 3 jurisdictions with all relevant clauses
- 2. DocX generator download document in DocX (or pdf) and continue in MS Word - tables, cross-references, styles, formatting - all stay fully functional also in DocX (and pdf)
- 3. Multi-lingual documents are drafted with one-time data insertion and choices
- 4. Apply automatically template theme styles, numbering, logo, header-footer etc according to your firm style or the client
- 5. Clause library all templates are cut into the smaller data points by ML clauses and variables.
- 6. Document bundles draft as many documents as necessary in bundle with one-time data insertion




DOCUMENT WORKFLOW. CORE FUNCTIONALITY



1 - automated templates

- A centralised library of automated templates
- Clause library for fast template creation and updates
- Document bundles, one-time data inserton



2 - smart drafting

- Scenario-based drafting
- Automated styles and formatting
- Real-view of choices and drafting; multi-lingual documents




3 - collaboration

- Co-drafting with team or external parties
- Attachments and task management
- Shared folders, groups and company view



4 - approvals


- Get rid of emails and collect all the approvals in one place


