1. Definitions

"Confidential Information" includes any and all technical or non-technical, tangible or intangible confidential information provided by Discloser to Recipient hereunder, which is (i) marked as such ("confidential", "proprietary", etc.) at the time of disclosure or (ii) by its nature or content should be reasonably deemed confidential to Recipient, regarding activities, products or services of Discloser and its affiliated companies or third parties, including without limitation:

a) Trade secrets and insider information;

b) Patent and patent applications;

c) Software source code, programs, documents, methods, algorithms;

d) Ideas, techniques, sketches, drawings, works of authorship, models, inventions, know-how, research, experimental work, development, design details, specifications, engineering
